♦ New Faculty

Jean Halley

Jean Halley is a professor of sociology at the Graduate Center and the College of Staten Island of the City University of New York (CUNY). She earned her doctorate in sociology at the Graduate Center of CUNY, and her master's degree in theology at Harvard University. Her book about touching children, breastfeeding, children's sleep and contemporary childrearing advice, Boundaries of Touch: Parenting and Adult-Child Intimacy was published in July 2007 by the University of Illinois Press. She assisted Patricia Ticineto Clough in editing The Affective Turn: Theorizing the Social in 2007 (Duke University Press). Halley co-authored Seeing White: An Introduction to White Privilege and Race (Rowman and Littlefield) with Amy Eshleman and Ramya Vijaya in 2011 and a second edition in 2022. And Halley's memoir and social history of cattle ranching in the United States, The Parallel Lives of Women and Cows: Meat Markets, came out with Palgrave Macmillan in 2012. Halley and Eshleman published Seeing Straight: An Introduction to Gender and Sexual Privilege with Rowman and Littlefield (2017). By Ron Nerio and Halley, The Roads to Hillbrow: Making Life in South Africa's Community of Migrants is out in 2022 with Fordham University Press. Halley's book with the University of Georgia Press about girls who love horses, Horse Crazy: Girls and the Lives of Horses,



came out in 2019. She and her horse grew up in the Rocky Mountains. Today she lives in New York City.

Ryan A. Smith

Ryan A. Smith's areas of research include the causes and consequences of race, ethnic and gender stratification at work, racial attitudes in America, and the functional use of religion during times of existential crises. His research has appeared in American Behavioral Scientist; American Sociological Review; Annals of the American Academy of Political and Social Science; Annual Review of Sociology; Du Bois Review; Religions; Review of Religious Research; Social Currents; Social Forces; Social



Problems; Social Science Research; Sociological Quarterly; and Work and Occupations.

Dr. Smith has served on the editorial board of Social Problems and has been a reviewer for Administrative Science Quarterly, American Sociological Review, Work and Occupations, Human Resource Management Journal, Law and Society Review, Rutgers University Press, and the National Science Foundation. He is a frequent guest lecturer, workshop facilitator, moderator, panelists and consultant to numerous nonprofit, for-profit and government agencies on a variety of issues pertaining to diversity, equity and inclusion in the workplace, the role of race in America, and social policies designed to increase equality of opportunity at work.

Dr. Smith is a former Scholar in Residence at the W.E.B. Du Bois Institute for African and African American Research at Harvard University. He also served as the Lillie and Nathan Ackerman Chair of Social Justice at the Marxe School of Public and International Affairs at Baruch (2012 – 2015). He received his Ph.D. in Sociology from the University of California, Los Angeles, his M.S. from the University of Wisconsin-Madison, and his B.A. from the University of Pennsylvania.

Soc.81100: Dissertation Proposal Development Seminar Profs. Van Tran/Julia Wrigley

This seminar provides an opportunity to develop a dissertation research project that will result in a complete draft of your dissertation proposal. In this seminar, you will formulate a research project, develop a theoretical argument, design a research strategy, propose a data collection plan, and present your proposal in a precise and compelling narrative form. By the end of the semester, you will be expected to have your draft of the dissertation proposal.

This seminar is designed with three objectives in mind. First, it will guide students through the process of producing a high-quality dissertation proposal. Second, it will provide a writing space and structure for students to work on their dissertation proposals. Third, we will discuss the challenges in the research and writing process as well as practical strategies for navigating them.

FELLOWSHIPS & GRANTS

Vera-CUNY Graduate Center Summer Fellowship 2023

Deadline: March 17, 2023

The Vera Institute of Justice and CUNY Graduate Center invite applications for Summer Fellows who will be based in Vera's New York City office. These \$4,000 fellowships will be offered to Graduate Center Ph.D. students from any program with research interests in criminal or immigration justice and the work of the Vera Institute. The primary responsibilities of the award winners will be to collaborate with researchers in one of Vera's 4 centers or programs on research relating to a specific project, including but not limited to data collection, analysis, fieldwork, report writing, stakeholder engagement, and dissemination.

Fellowship recipients will work with their assigned initiative for 120 hours over the summer of 2023. While there is some flexibility in remote working, fellows will be expected to work onsite at Vera's offices in Sunset Park Brooklyn for at least 60 hours over the course of the summer in line with Vera's hybrid schedule. In addition, recipients will be required to attend a welcome reception at the beginning of the fellowship, to do a brief presentation on their work at the end of the summer and write a blog post about their experiences before the end of the Fall 2023 semester.

2023-2024 Graduate Student Public Humanities Fellowship

Deadline: March 20, 2023

Humanities New York and its nine partner universities, comprising the Humanities Centers Initiative, invite grant proposals from advanced graduate students in support of public programming and projects. Grant proposals for projects that are underway or already in development are highly encouraged. Projects may be collaborations between two or more students; however, the application should designate one as the project director. Preference will be given to applicants who have not previously been awarded the Humanities New York Public Humanities Fellowship. All projects must be public-facing in some way: intended for public audiences, engaging members of the public as collaborators, or partnering with community groups. Projects of any format or type will be considered; however, projects that engage with issues of social justice and equity are particularly welcome. Grantees will also have the opportunity to take part in workshops and networking events held by the HCI partners, designed to introduce them to different skillsets and to experts of the public humanities, in order to enrich their practice.

2023-2024 Office of Institutional Research and Effectiveness Fellows Program

Deadline: March 24, 2023

<u>The Office of Institutional Research and Effectiveness (OIRE)</u> is seeking two Research Analysts for its Fellowship Program. OIRE is an administrative unit within the Provost's Office at the GC. It provides leadership in the areas of

institutional effectiveness, data analytics, student learning assessment, program evaluation, and regional accreditation. The OIRE Fellows Program provides vital support to the office. We seek applicants with experience, skills, and/or strong interest in working in the areas of data analytics, research, assessment, and/or higher education administration.

All full-time doctoral students in good academic standing are eligible to apply. Students holding one of the GC's multi-year fellowships and tuition fellowships are also welcome to apply. Effective with the Fall 2023 semester, this OIRE graduate fellowship requires fellows to work a total of 450 non-teaching hours during the academic year (15 hours/week).

Compensation for the fellowship will be a minimum of \$27,374 for the academic year. Fellows will be appointed to the Graduate Center payroll as Graduate Assistant Bs (GAB) at their own current rate and receive a Provost's Award in the amount of \$14,159 that will pay through the Office of Financial Aid. The GAB title provides eligibility to purchase the low-cost NYSHIP health insurance as well as in-state tuition remission for fellows who are within their first 10 registered semesters of doctoral study. Fellows who are past their 10 registered semesters of doctoral study will be eligible to receive in-state tuition remission at the Level 3 rate as per the new PSC- CUNY contract (this benefit provides for this tuition remission for a maximum of 4 semesters past the student's 10th registered semester).

Include a CV (no more than 4 pages), and a brief cover letter (no more than 1 page) describing your interest, skills, and relevant experience for the position. 2023 Fulbright-Hays Doctoral Dissertation Research Abroad Fellowships

The Fulbright-Hays Doctoral Dissertation Research Abroad Program (DDRA) funds dissertation level doctoral students to conduct research in modern foreign languages and area studies for periods of 6 to 12 months. This program is sponsored by the U. S. Department of Education (ED) and is not related to the IIE Fulbright program. The Fulbright-Hays DDRA Program is for students who intend to conduct dissertation research outside of the United States and Western Europe, and is of particular interest to students in the social sciences and humanities. Students must be US Citizens or Permanent Residents to be eligible.

Please note that because Fulbright-Hays awards are granted to students through their educational institutions, all applications must be submitted to the Graduate Center's Provost Office prior to being submitted electronically to the Department of Education. Given the timing of the current application period, the Graduate Center's internal deadline will be Tuesday, March 28, 2023 5:00 p.m. in order to allow for proper review and assembly of applications prior to the Education Department's transmittal deadline of April 11.

GC Digital Initiatives is searching for new doctoral students to join our dynamic team. Together, GC Digital Fellows lead week-long digital research institutes, teach workshops on technical skills, create resources for GC students and faculty, and build digital projects that make use of the affordances of emerging technology while considering the ethical, social, and political stakes. In fact, the GC Digital Fellows are twice-recognized by the National Endowment for the Humanities (NEH) for their digital pedagogy and in the next two years will work with a research team to develop new workshops for GC students that will also be used nationally.

Graduate Center doctoral students at any level are eligible to apply, and we encourage applications from women and gender minorities and BIPOC. We hope to add strength to our program in graphic and web design, Python, and mapping; however, this is not an exhaustive list. We encourage those with other skills and interests to also apply.

This fellowship requires reflection, flexibility, collegiality, and willingness to engage in educational support activities that lay crucial foundations for community college students' learning, thriving, and success. It offers an ideal opportunity for Graduate Center students committed to public higher education, social justice, thinking about the humanities in community college contexts, and supporting CUNY undergraduates. Fellows can expect to strengthen their skills in pedagogy, programmatic support, project management, leadership, events planning, and community building that will serve them in a wide range of career pathways. Graduate fellows will be assigned to work with one of four campus partners. Fellows will also have opportunities to connect and collaborate with the Graduate Center's Teaching and Learning Center, The Futures Initiative, and other partners throughout the CUNY system. CUNY Humanities Alliance Fellowships offer annual compensation of approximately \$29,000 (or more, depending on prior service or appointment history with the Graduate Center). All applicants must be a full time Graduate Center doctoral student, in good academic standing, and entering years 3-5 of study in Fall 2023.
